  - The application should be strictly as per the pro-forma prescribed. Application not accompanied by the prescribed forms and copies of relevant merit/participation certificates will be liable for rejection.
  - Only one application should be submitted by the candidate. If any candidate submits more than one application, all such applications will be summarily rejected and the candidate will not be eligible.
- The application should be filled up in Block Letters in English using ballpoint pen preferably in **Black ink**.

**8. ELIGIBILITY CONDITIONS**

- I. The candidate must be a citizen of India.
- II. **AGE LIMIT:** The candidate must be of 18 to 27 years of age on 13/09/2025. However, relaxation up to a maximum of 5 years (10 years in the case of those belonging to SC/ST category) shall be allowed in accordance with the provisions of the Department of Personnel & Training (DoP&T) Office Memorandum No.15012/3/84-Estt.(D) dated 12.11.1987.

**Note-** Age relaxation as mentioned above will be admissible only to those sportspersons, who satisfy all other eligibility conditions related to education and sports qualifications, backed by a certificate in the prescribed form, from an authority, as detailed in this Notification.

### IV. SPORTS ELIGIBILITY:

The proficiency will be evaluated on the basis of their participation in recognized tournaments/events in the calendar years 2025, 2024, 2023, 2022, 2021 and 2020 for which details should be furnished as Annexure-B Part-I. **Certificates of participation/achievements for which concerned forms issued by concerned Authorities are not enclosed, will not be considered for evaluating the proficiency.** The tournaments/events will be evaluated in the following descending order of importance.

**a) Order of Preference:-**

a) First preference to those candidates who have represented the country in an International Competition with the clearance of the Department of Sports, Ministry of Youth Affairs and Sports

(b) Next preference may be given to those who have represented a State/U.T. in the Senior or Junior level national Championships organized by the National Sports Federations recognized by Department of Sports, Ministry of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions upto 3<sup>rd</sup> place. Between the candidates participating in Senior and Junior National Championships/games, the candidates having participated and won medal in Senior National Championship should be given preference.

(c) Next preference may be given to those, who have represented a University in an Inter-University competition conducted by Association of Indian Universities/Inter University Sports Board Or Khelo India University Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions upto 3<sup>rd</sup> place in finals.

(d) Next preference may be given to those who have represented a State/UT in Khelo India Youth Games (age category above 18 years) or Khelo India Winter Games or Khelo India Para Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions upto 3<sup>rd</sup> place in finals.

(e) Next preference may be given to those who have represented the State Schools in the National sports/games for Schools conducted by the All-India School Games Federation and have won medals or positions upto 3<sup>rd</sup> place.

(If Next preference may be given to those who represented a State/Union Territory/ University /State Schools Teams at the level mentioned in categories (b) to (e) but could not win a medal or position, in the same order of preference.

**Note 1:** *In the event of tie those who have secured a higher position or won more than one medal may be given the preference.*

**Note 2:** *Participation in individual and team event/item may be given the same preference.*

**Note 3:** *No preference may be given for winning more than one medal/position.*

**Note 4:** *In case of any doubt about the status of a tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports, Ministry of Youth Affairs and Sports.*

**Note:-**Only the best three performances during the calendar years 2025, 2024, 2023, 2022, 2021 & 2020 will be considered for evaluation. These should be properly filled up in Annexure-B Part-I of the application.

**9. SELECTION OF THE CANDIDATES**

a) The applications will be scrutinized and suitable candidates will be shortlisted for further selection process. Department reserves the right to decide the number of candidates to be called for field trials based on the credentials of the candidates. The eligible candidates will have to appear in the field test relevant to Sports discipline.

Success in the above tests confers no right to appointment unless the department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.

b) Field trial will be conducted to check the fitness levels and performance of the candidates in the sports/games he had applied for. In case any candidate is unable to take the fitness test for any reason whatsoever or having taken the test is not found fit, he would not be considered for the post. The current form will be evaluated based on the year of participation in recognized tournaments/events in the calendar years 2025, 2024, 2023, 2022, 2021 and 2020 for which the details should be furnished as per Annexure-B Part-I.

c) The shortlisted candidates will be called for data Entry Speed Test (in case they have opted for the post of Tax Assistant), Examination of Physical Standards & Physical Efficiency Test (in case they have opted for the post of Havaldar). The field trials along with Data Entry Test and Physical Efficiency Test will be held in Guwahati. The selected candidates will be required to appear for the same at their own expenses on the dates and time to be indicated later.

**10. The applicant should enclose attested copies of the following certificates:-**

- (i) Matriculation/SSC or equivalent certificate for proof of age
- (ii) Education qualification Certificate.
- (iii) Sports/games certificates/forms as mentioned in Annexure-A (Form-1, 2, 3, 4, 5).
- (iv) Caste certificate (in support of claim)
- (v) NOC from present employer, if applicable.
- (vi) Aadhar Card.
- (vii) Recent Passport Size Photo (to be affixed on the application form).

**11. General Instruction to the applicants:-**

- i) The applicant has to go through the notification, eligibility criteria, instruction to candidates, vacancy positions, other conditions and instructions etc., carefully before filling up the application form in the given format.
- ii) Recent passport size photograph should be affixed on the Application in the space provided for the said purpose.
- iii) Application not containing the required details/enclosures, or which are incomplete and/or unsigned will not be entertained/considered.
- iv) Failure to comply with the instructions/conditions prescribed in this recruitment advertisement/notice will result in rejection of the application, and no such intimation will be served, nor any communication in this regard will be entertained.
- v) The candidate can apply for more than one post in a single application, but **only one application should be submitted by the candidate**. If any candidate submits more than one application, all such applications will be summarily rejected.
- vi) If a candidate desires to be considered for more than one game/sport, the candidate may select the relevant games/sports while filling the single application form. In no circumstance, the candidate should submit more than one application.
- vii) The applicant should clearly indicate the preference of the posts in the application form to which he is applying, as first preference, second preference, third preference etc.
- viii) Failure to indicate the posts in the column "Post applied for" will make the application liable for rejection without any further correspondence.
- ix) Candidates seeking relaxation benefits must ensure that they are entitled to such relaxation as per the eligibility prescribed in the notification and furnish relevant documents in support of the same.

- xi) The Candidate should be clear in all the Doping tests done by the World

Anti-Doping Agency (WADA), National Anti-Doping Agency (NADA) or any other relevant authorities.

xii) Further, there should be no ongoing investigation against the candidate regarding Doping or using unfair means of any nature to compete or win in any of Sporting event. A declaration to this effect must be given by the candidate.

xiii) The format of certificates and the competent authorities for issuing the certificates of achievements are mentioned at Para No. 7 above.

xiv) The certificates of sports achievements submitted in any other form, or from authorities not competent to issue the same, will be ignored.

xv) Sportsperson who are already employed in Central Government or State Government departments/organization or PSUs should furnish an NOC from the present employer.

xvi) The candidates will be intimated about any information regarding the recruitment process on their E-mail ID or Phone number mentioned in their respective application form.

## **12. Terms and Conditions governing the application:-**

i) The eligible applicants will be shortlisted by this office and called for a proficiency sports trials, only if required, and the date, time and venue of such trials/tests will be communicated in the course of time.

ii) The candidates are required to make their own arrangements for attending such proficiency trials, if called for, by this office. Success in the above tests confer no right to appointment unless Department finds the candidate suitable.

iii) The Selected candidate are liable to be posted anywhere in Guwahati Zone.

iv) The selected candidates will be on probation for 2 years or such period as per the extant instructions of the Government of India. His/her participation in the tournaments / meets on behalf of the Department will also be a deciding factor in the declaration of his/her probation. The selected candidates will be required to represent the CGST, Central Excise and Customs Department, Guwahati Zone, in the tournament/meets as decided at least for ten (10) years. **The selected candidates will also be required to sign an undertaking that he will not seek inter-zonal transfer for a period of 10 years.**

v) In the event of any tie the decision of the appointing authority will be final.

vi) The Principal Commissioner of CGST, Guwahati Commissionerate has got the right to cancel the recruitment process, at any stage without assigning any reason thereof.

vii) Any form of canvassing by any candidate will render his/her candidature liable to be rejected summarily at any stage of the recruitment process.

viii) The selected candidates should produce all the relevant certificates in original for verification at the time when they are called for.

ix) Medical fitness of the candidates will be ascertained before their formal appointment.

x) The appointment of the candidates will be subject to clearance received in this regard from the Police authorities of their current place of residence after verification.

xi) If at any stage during the recruitment process, the candidate is found to have furnished any wrong information, statement or declaration or falsified/misrepresented any facts, his/her candidature/appointment will be liable for cancellation.
